Ethical rules for all federal judges, term limits for Supreme Court justices, and institutional guardrails for the DOJ should become law. It cannot be a matter of custom when the public's trust has been eroded.

3. Civic engagement

We cannot sustain democracy from the top down. We need informed citizens, citizens engaged with the law, who know it and care about it. Civic education, media literacy, and public advocacy must become part of a national effort to protect against the next demagogue.

4. Defending the truth

In this country, the truth is no longer the property of all. In the service of our political causes, the truth is partisan. Courts, however, do not operate on emotion. Without a shared foundation of facts, rulings will be seen as weak, because they are.
